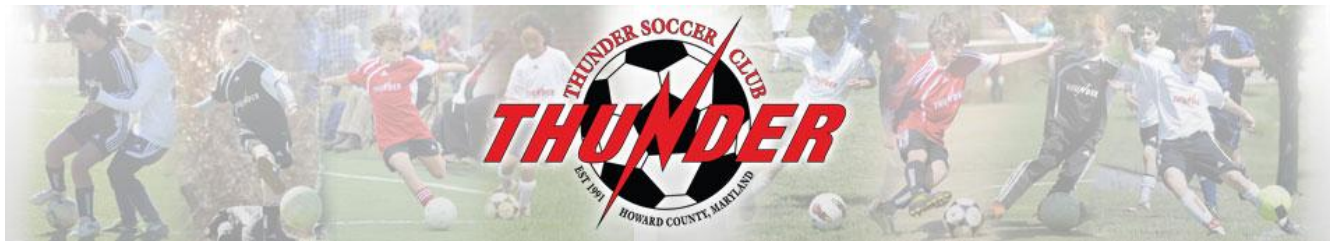

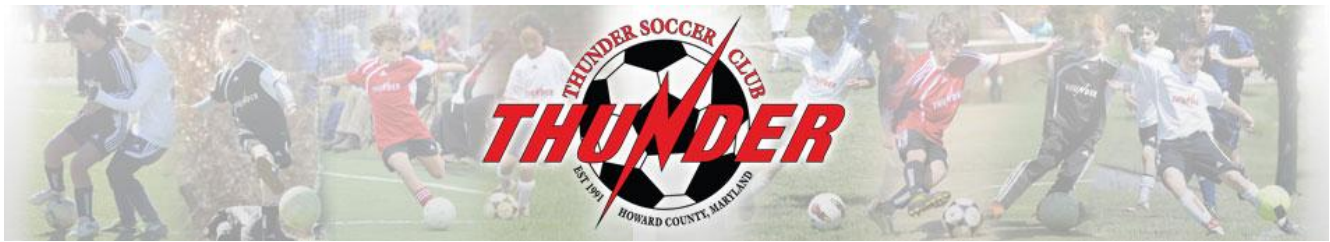

TSC 2013 Super Y League Season Player/Club Expectations Agreement

Congratulations on being selected to join the Thunder SC (TSC) Super Y League Team. Your skills and hard work have earned you a spot on one of the top soccer clubs in the United States. Our coaches, staff and Board of Directors hope that this will be an enjoyable experience for you and your family. As part of the process, we want to ensure that you are fully aware and understand the commitments TSC is making to you at this time, and our expectations and the obligations incurred by you as a result of accepting the position offered to you. Every player and parent/legal guardian will be asked to acknowledge their understanding of the mutual commitment and expectations between you and TSC. Accepting the position offered, obligates each player to pay the **full non-refundable registration fee**, regardless of whether the player after executing this agreement completes the proper paperwork for the issuance of a USSSA player pass or later decides to leave TSC prior to the end of the Super Y League.

Thunder SC reserves the right to temporarily suspend and/or terminate a player's participation in TSC's program in the event of failure, on the part of the player or parent/legal guardian, to abide by this agreement or other TSC rules. In the event of either suspension or expulsion of a player there will be no reimbursement of any paid fees or expenses.



Players & Parents/ Legal Guardians Responsibilities

1. Thunder SC is a competitive soccer club; **there is NO guarantee of minimum playing time on the Super Y League team.** The Technical Director and the Director of Coaching will handle all unresolved disputes between coaches and players, and any decisions by the TD, DOC or the TSC Board of Directors are final.
2. With only 18 players being allowed to participate in any particular game, there will likely be occasions whereby players have to sit-out due to not being selected to the game-day roster. These decisions are made by the Head Coach and are final.
3. Players shall make a full commitment to the Super Y League Team. Players shall not participate in any other Super Y League soccer program.
4. There will be other team expenses above and beyond the Super Y registration fee. Expenses may include, but are not limited to, uniforms (or other extra soccer gear), hotels, and other travel costs associated with attending games and practices. Any expenses common to the team (such as a collective team decision to rent buses) will be collected and handled by the team's Manager. With Club pre-approval, the team may seek and receive donations and/or fundraise to defray these expenses. All donations and/or fundraising amounts raised must be deposited into the TSC team account and then may be used to pay for appropriate team expenses. These funds will remain with TSC should the player decide to leave the Club.
5. In the event a player requests to be released from a Super Y League team prior to the completion of the season, the player agrees to pay TSC any outstanding amounts owed, prior to any release being processed. In this event the departing player shall not enroll in any other soccer club or academy until all outstanding fees are satisfied by the departing player to TSC and a release letter issued by TSC.
6. Each player and parent/guardian has received and read this Player/Club Expectations Agreement, the TSC Code of Ethics, the TSC Code of Conduct for Travel, and the TSC Liability Release and agrees to abide by them. By signing below, each player and parent/legal guardian accepts a position with TSC and agrees to act in a respectful manner at all activities, practices, games, travel, etc, and to serve as a role model for others to maintain the dignity of ourselves, our teams, and all of TSC. TSC is a MSYSA, US Club, and United Soccer Leagues affiliated organization and its players and parents will conduct themselves in accordance with and be governed by TSC, MSYSA, US Club, and USL policies and rules at all times. TSC reserves the right to modify, at any time, the referenced Code of Ethics and Code of Conduct for Travel, as well as to approve additional rules and policies which will be binding upon the player and parent/guardian, and/or request additional releases on behalf of the player and his/her parent/legal guardian.
7. Privacy notice and distribution of electronic mail and postal mailing addresses. For both internal and external use, TSC may compile and distribute email and postal mailing addresses and/or lists.
8. The player and the parent/guardian authorize TSC to obtain, use and publish the player's name, photographs and video of the player, and the parents/guardians, on our website or in game write-ups to newspapers etc, while involved in TSC activities. The player and the parent/guardian forever assign, to TSC all rights over the referred material and forever waive all rights to compensation for such use and publication.

Code of Ethics

All players, coaches and spectators will be bound by the following while participating in TSC sanctioned events.

Players

- I will encourage good sportsmanship from fellow players, coaches, officials and parents at all times.
- I will remember that soccer is an opportunity to learn and have fun.
- I deserve to play in an environment that is free of drugs, tobacco, and alcohol; and expect everyone to refrain from their use at all soccer games, events and activities.
- I will do the best I can, remembering that all players have talents and weaknesses the same as I do.
- I will treat all coaches, players, game officials, administrators, and fans with respect at all times; regardless of race, sex, creed, or abilities, and I will expect to be treated accordingly.
- I will concentrate on playing soccer always giving my best effort.
- I will play by the rules at all times.
- I will place the emotional and physical well being of all players ahead of any personal desire to win.
- I will at all times control my temper, resisting the temptation to retaliate.
- While traveling, I shall act in a manner so as to be a credit to myself, my team, and the Club.

Parents/Legal Guardians/Spectators

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, game officials, Club officials, league officials, and administrators at all times.
- I will place the emotional and physical well being of all players ahead of any personal desire to win.
- I will support the coaches, officials, and administrators working with my child, in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the players not for the adults.
- I will ask my child to treat other players, coaches, game officials, Club officials, league officials, administrators, and fans with respect.
- I will always be positive.
- I will always allow the coach to be the only coach.
- I will not get into arguments with the opposing team's parents, players, game officials or coaches.
- I will not come onto the field for any reason during the game unless requested by an official to do so.
- I will not criticize game officials.
- Alcohol, tobacco, illegal drugs and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during or after any game or at any other time at the field and/or game complex.

Player Code of Conduct for Travel

Our off the field behavior and character are as important as our on the field performance. The following are the TSC guidelines, rules, and regulations that must be adhered to while traveling.

At the coach's discretion, players may be sent home at additional expense to the parent if they violate serious behavior rules such as those related to drugs, drinking, illegal activities, and tobacco products or having members of the opposite sex in their rooms at any time.

TSC SPONSORSHIP / OFFICAL ADIDAS GEAR

All members of TSC are expected to cooperate with our current sponsors in a reasonable fashion as requested. Specifically, traveling TSC players must make sure that their uniform and all uniform accessories, including warm-ups and equipment bags, are compliant with Club policies.

TRAVEL DRESS / BEHAVIOR / DECORUM

While traveling, players must wear proper attire such as Polo tops and Khaki bottoms. The minimal standard dress code while traveling will be no cut offs, no hats. Clothes shall "fit"; nothing too tight or too loose. No holes or tears in the clothing shall be present. Disrespectful slogans, wording or political statements, shall not be acceptable. A higher standard may be established by the Head Coach when desired. At no time will the Head Coach set a lesser standard then set forth in the Rules and Regulations.

ROOM REQUIREMENTS

At no time will anyone of the opposite gender be allowed in each other's rooms while Club travel is taking place. Players are expected to stay in their assigned room or with their parents/guardians.

TRAVEL CURFEW

The Head Coach will determine a team curfew.

TRAVEL RESPONSIBILITIES

Players are expected to travel, stay, and participate with the team throughout the entire event. The entire event is defined as when the player arrives at the home airport or point of departure through when the player returns to the home airport, or point of return from the trip, or at the conclusion of the specific tournament or event. Any exceptions will be granted and determined by the Head Coach. As a common practice, all participants on the trip are expected to be polite, positive, well-mannered, cooperative, good sports, respectful and considerate of others - those you encounter along the way as well as those with whom you are traveling. Rooms, vehicles, and premises are to be kept clean.

There are times when players may be without direct adult supervision. When this occurs, a designated adult must know where you are and when you will be back. At the same time, it is always your responsibility to a) know how to find one of the adults, b) know when and where you are expected to be next, and c) be there on time. When you are without adult supervision, you must always follow the "Rule of Three" - at least three players must be together.
